RULES & REGULATIONS

- 1- Payments can be made through Bank Draft/Pay Order/Cash in favour of Park View Enclave (Pvt) Ltd.
- 2- All Applicants will abide by these Rules & Regulations in addition to any other procedural By Laws, Rules & Regulations governing Allotment Positions, Membership, Construction and Transfer of Plot.
- 3- For a Corner, Main Boulevard & Park Facing 10% extra amount will be charged separately.
- 4- Installments received after the Due Date from the Allottee/ Applicant will only be accepted with extra charges @ 3% per month.
- 5- Only 1 Form can be used to reserve One Plot/Villa, for more than one booking separate Forms are to be used for each additional Plot/Villa.
- 6- In the Event of Cancellation of Allotment by Allottee (or Allotment Cancellation due to Non-Payment or due to not paid Installment) Management of Park View City has the right to Allot or Sell the said Plot to any other person and previous Allottee will have no right to the said Plot. The Final decision will rest in the hand of Management which can't be challenged at any Forum.
- 7- No Interest/ Markup will be paid in case of a refund, an amount of 20% of the Deposits will be deducted as Service Charges.
- 8- Plot allocated of an Applicant shall not be used for any other purposes other than that Applied/ Meant for.
- 9- Applicant(s) can only transfer the Plot/Villa after the payment of UpToDate described charges, as per the Payment Plan.
- 10- In the event of Sale/Conveyance Deed Registration, all Registration/Mutation Charges shall be borne by the Allottee. Transfer Fee fixed by Park View City Management stands payable.
- 11- The Applicant will pay Development Charges as and when demanded by the Management of Park View City.
- 12- Development Charges include Road, Sewerage, Water Supply, Electricity, Gas and Overhead Water Tanks.
- 13- The Applicant will pay Possession & Demarcation Charges when applied for it. Charges will be decided by the Management at the time of possession.
- 14- If an Allottee fails to pay 2 successive Installments within the prescribed period. The allotment shall liable to be cancelled, in such case the paid amount shall be refunded to Allottee after 20% deduction as service charges.
- 15- In case of withdrawal of an Application by the Applicant, an amount of 20% shall be deducted as Service Charges of paid amount.
- 16- In case of a dispute, between Member and Park View City Management, The decision of Park View City Management shall be taken as final and has to be accepted by the Member.
